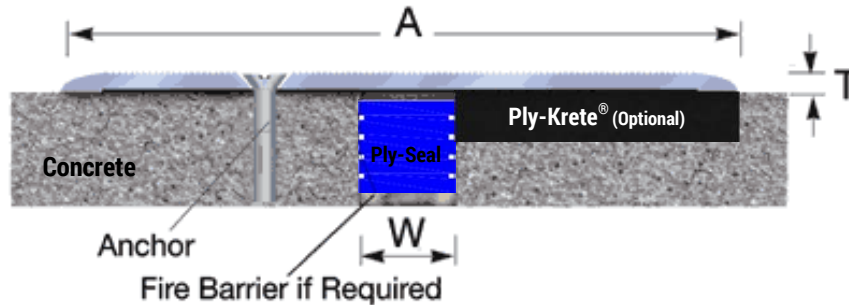


# Ply-Seal® Cover Plates

**Ply-Seal®** Cover Plates may be used to protect the **Ply-Seal®** joint seal from certain traffic conditions and reduce the 'bump' as traffic passes.

### Uses

**Ply-Seal®** Cover Plates may be used in pedestrian areas, parking garages, plazas, airport terminals, and many other commercial locations, interior or exterior.

**Ply-Seal®** Cover Plates may be used with **Ply-Krete®** elastomeric concrete on each side of joint to extend the life expectancy. Site conditions usually determine the required block out size for the **Ply-Krete®** elastomeric concrete.

### Limitations

As with most cover plates there should be a smooth transition area for the plates to glide on. Any elevation differences between the opposing joint faces may reduce the life expectancy of the covers and/or cause damage to traffic.
